- 1. Write each of these statements in the form "if p, then q" in English.
  - (a) (2 points) I will remember to send you a request only if you remind me to do so.

**Solution:** If I remember to send you a request, then (because) you remind me to do so.

(b) (2 points) To be a member of this club it is sufficient that you attend weekly meetings.

Solution: If you attend weekly meetings, then you will be a member of this club.

(c) (2 points) There is a traffic jam whenever it rains in Ankara.

Solution: If it rains in Ankara, then there is a traffic jam.

(d) (2 points) That you get this award implies that you had the best credentials.

Solution: If you get this award then you have the best credentials.

(e) (2 points) It is necessary to have a valid password to log on to the server.

Solution: If you log on to this server then you have a valid password.

2. (7 points) Prove that  $\sqrt[n]{2}$  is an irrational number for all  $n \ge 2$ .

**Solution:** Let n be an arbitrary integer  $n \ge 2$ . Below we prove the statement for this arbitrary n and use existential generalization.

Assume for the sake of contradiction that there exist  $a, b \in \mathbb{Z}$  such that  $\sqrt[n]{2} = \frac{a}{b}$ . Update a and b using cancellation such that they do not have any common divisor (a, b) become relatively prime after the necessary cancellations).

Then, we observe taking the *n*th power of  $\sqrt[n]{2} = \frac{a}{b}$  gives  $2b^n = a^n$ , implying that 2|a. However, if 2|a, then the RHS has  $2^n$  as a factor implying also 2|b. This means that 2 divides both *a* and *b*, which is a contradiction with the choice of *a* and *b*.

3. (10 points) Prove that for any two real numbers x and y,  $|x+y| \le |x|+|y|$ . (|x| indicates the absolute value of x, that is |x| = x if  $x \ge 0$ , and |x| = -x if x < 0.)

Solution: We consider the following cases:

•  $x, y \ge 0$ : Then  $|x + y| = x + y \le |x| + |y| = x + y$ .

• 
$$x, y \le 0$$
: Then  $|x + y| = -(x + y) \le |x| + |y| = -(x + y)$ .

•  $x \ge 0, y < 0$ : We have two subcases: If  $|x| \ge |y|$ , then  $|x + y| = (x + y) \le |x| + |y| = x - y$ . If |x| < |y|, then  $|x + y| = -(x + y) \le |x| + |y| = x - y$ . 4. (6 points) Prove that if there are 40 students in the class then at least two students have names that begin with the same letter. (Note: Turkish alphabet has 29 letters.)

**Solution:** Assume for the sake of contradiction that no two students' names start with the same letter. This means at most one student for each letter, hence at most 29 students are in the class, a contradiction with the fact that there are 40 students.

- 5. For primitive statements p, q, r,
  - (a) (4 points) Verify that  $p \to [q \to (p \land q)]$  is a tautology using a truth table.

(b) (7 points) Verify that  $((p \lor q) \land \neg p) \to q$  is a tautology without using a truth table. Clearly state your steps.

(c) (7 points) Show that  $p \lor q \lor (\neg p \land \neg q \land r) \Leftrightarrow p \lor q \lor r$  without using a truth table. Clearly state your steps and reasons.

- 6. Prove each of the following.
  - (a) (8 points) Let a, b be two positive integers. Prove that if a and b are perfect squares, then the product of ab is also a perfect square ( $x^2$  is a perfect square, where x is an integer).

#### Solution:

Here, we are using direct proof. Since a and b are perfect squares, it can be written as  $a = x^2$  and  $b = y^2$  where a, b are positive integers. Using the associative and communicative laws of multiplication for integers, we find that  $ab = (x^2)(y^2) = (xx)(yy) = ((xx)y)y = ((x(xy))y = ((xy)x)y = (xy)(xy) = (xy)^2$ . Thus ab is also a perfect square.

(b) (8 points) For all real numbers x, y, if  $x + y \ge 100$ , then  $x \ge 50$  or  $y \ge 50$ 

**Solution:** Here, we will prove it by establishing the truth of its contrapositive. Since we will be use the negation of the conclusion, let x < 50 and y < 50, then x + y < 50 + 50 = 100. We have the negation of the hypothesis. Therefore, by contrapositive, this result proves that for all real numbers x, y, if  $x + y \ge 100$ , then  $x \ge 50$  or  $y \ge 50$ . 7. (10 points) Show that the following is a tautology, without using a truth table. Clearly indicate the applied rule at each line of your deduction:

$$((p \to q) \land (r \to q)) \to ((p \lor r) \to q)$$
