1. (14 points) Write down the recursion tree for the N-queens algorithm below for $n=3$. Show the positions of the queens at each node of the recursion tree.

RecursivenQueens \((Q[1 . . n], r)\) :

2. (10 points) Let $w=0110$ an input for a turing machine. Which of the following are not valid for given configurations? ( $q_{i}$ represents any state's name)

## Solution:

true: $q_{1} 0110 \vdash 0 q_{1} 110$
true: $01 q_{1} 10 \vdash 0 q_{2} 110$
false: $011 q_{2} 0 \vdash 0 q_{2} 110$
false: $01 q_{1} 10 \vdash 0 q_{2} 111$
true: $01 q_{2} 10 \vdash 0 q_{2} 010$
3. (12 points) The patients at a doctor's office are waiting for their appointment. There are $*_{\mathrm{n}}{ }^{*}$ patients waiting and there are estimated times corresponding to each patient's problem. So, patient $i$ requires $t_{i}$ minutes to be examined. Say, if the patients were examined in the order $t_{1}, t_{2}, \ldots, t_{i}$, then the $i$ 'th patient's waiting time would be $\sum_{k=1}^{i} t_{k}$ minutes. Let the total waiting time be $T$ below.

$$
T=\sum_{i=1}^{n} \text { Total waiting time for patient } i
$$

(a) Give an algorithm that would find the optimal order minimizing $T$.
(b) Give a short proof showing that your algorithm indeed outputs the minimum $T$.

## Solution:

(a) First order $t_{i}$ 's in increasing order, then follow this order for examinations.
(b) Assume that this order does not give the optimal solution (minimum $T$ ) and one of the optimal solutions has a pair of $\left(t_{i}, t_{j}\right)$ such that $t_{i}>t_{j}$ and patient $i$ comes before patient $j$. Switching the positions of $t_{i}$ and $t_{j}$ changes (only) the waiting time for patient $i$ by $t_{j}$ and the waiting time for patient $j$ by $-t_{i}$, hence changing $T$ by $t_{j}-t_{i}<0$. Since this contradicts with the optimality of this solution, there cannot be any such pair in an optimal coloring.
4. (12 points) If $L$ is a decidable language, determine which of the following are true/ false.

## Solution:

(a) true: $L$ is recognizable
(b) true: $\bar{L}$ is recognizable
(c) true: $\bar{L}$ is decidable
(d) true: There is a Turing machine that halts on all inputs, accepting every string in *L.*
5. (18 points) Let $X \leq_{P} Y$. Determine whether the following are true/ false.

## Solution:

(a) false: $X$ is in P
(b) true: If $Y$ is in P , then $X$ is in P .
(c) true: If $X$ is NP-hard, then $Y$ is NP-hard.
(d) false: $Y$ is NP-hard.
(e) false: If $S A T \leq_{P} Y$, then $X$ is NP-hard.
(f) true: If $S A T \leq_{P} X$, then $Y$ is NP-hard.
6. The recursion tree for the algorithm RecFibo has running time, the leaves are always 0 or 1 .
(a) (6 points) Use induction on $n$ to show that there are exactly $F_{n} 1$ 's and $F_{n-1}$ 0's as the leaves.
(b) (6 points) In that case, how many intermediate nodes does this full binary tree with have? Show all your work to receive full credit.

## Solution:

(a) Since we are showing that there are exactly $F_{n} 1$ 's and $F_{n-1} 0$ 's as the leaves in the recursion tree calculating $F_{n}$, the base case has $n=1$ and $n=2$.
Base case:
The tree for $n=1$ has $F_{1}=1$ ''s (the root) and $F_{0}=00$ 's.
The tree for $n=2$ has $F_{2}=11$ 's and $F_{1}=10$ 's.

Inductive case: Assuming that the claim holds for the recursion tree calculating $F_{n-1}$, call it $T_{1}$, and $F_{n-2}$, call it $T_{2}$ (by the induction hypothesis), we prove it for $F_{n}$. The recursion tree for $F_{n}$ has a root vertex whose children are the roots of the subtrees $T_{1}$ and $T_{2}$. Hence, we have:

- $F_{n-1}$ 1's in $T_{1}$ and $F_{n-2}$ 1's in $T_{2}$ giving a total of $F_{n}$ 1's as the leaves, - $F_{n-2}$ 0's in $T_{1}$ and $F_{n-3}$ 1's in $T_{2}$ giving a total of $F_{n-1}$ 0's as the leaves.
(b) Let $i$ be the number of intermediate vertices, $\ell$ be the number of leaves, and $x$ be the total number of vertices. We have $x=i+\ell$.
If we direct the edges in the tree away from the root and obtain a directed tree, all internal vertices become parents of exactly two vertices, except the leaves. So, $2 i=x-1$, where we subtract 1 because all vertices but the root has a parent. Combining this with $x=i+\ell$, we get $2 i=i+\ell-1$. So, $i=\ell-1=F_{n}+F_{n-1}-1=F_{n+1}-1$.

7. (12 points) Determine whether the following statements are true/false for a graph $G$ on $n$ vertices that has an independent set with $k$ vertices.

## Solution:

(a) (3 points) false: The complement of $G$ has a vertex cover with $k$ vertices
(b) (3 points) true: $G$ has a vertex cover with $n-k$ vertices
(c) (3 points) true: The complement of $G$ has a clique with $k$ vertices
(d) (3 points) false: $G$ has a vertex cover with $k$ vertices
8. (10 points) Write the following formulas $\phi_{1}$ and $\phi_{2}$ as a 3-CNF (Conjunctive Normal Form), call them $\phi_{1}^{\prime}$ and $\phi_{2}^{\prime}$, so that $\phi_{1}$ is satisfiable if and only if $\phi_{1}^{\prime}$ is satisfiable, and $\phi_{2}$ is satisfiable if and only if $\phi_{2}^{\prime}$ is satisfiable:

\phi_{1}=\left(x_{1} \vee x_{2} \vee \neg x_{4}\right) \wedge\left(x_{2} \vee \neg x_{3}\right) \wedge x_{5} \\
\phi_{2}=x_{1} \vee x_{2} \vee \neg x_{3} \vee x_{4} \vee \neg x_{5}
\end{gathered}
$$

&\left(x_{5} \vee v \vee w\right) \wedge\left(x_{5} \vee v \vee \neg w\right) \wedge\left(x_{5} \vee \neg v \vee w\right) \wedge\left(x_{5} \vee \neg v \vee \neg w\right) \\
& \phi_{2}^{\prime}=\left(x_{1} \vee x_{2} \vee u_{1}\right) \wedge\left(\neg x_{3} \vee \neg u_{1} \vee u_{2}\right) \wedge\left(x_{4} \vee \neg x_{5} \vee \neg u_{2}\right)
